In the period from 25 July 2017 until 31 July 2017 Van Lanschot Kempfen has repurchased 4,500 of its own shares. The shares were repurchased at an average price of €25.23 per share for a total amount of €113,527.

These repurchases are part of the share buy-back programme for at most 150,000 of own shares, which was announced on 7 June 2017. The total number of shares repurchased to date is 48,500.
