Van Lanschot Kempen: update on share buy-back programme 29 August 2017 – 4 September 2017

In the period from 29 August 2017 until 4 September 2017 Van Lanschot Kempen has repurchased 7,150 of its own shares (depository receipts for Class A ordinary shares). The shares were repurchased at an average price of €26.87 per share for a total amount of €192,115.

These repurchases are part of the share buy-back programme for at most 300,000 of own shares, which was announced on 7 June 2017 and 29 August 2017. The total number of shares repurchased to date is 109,780.
