Van Lanschot Kempen: update on share buy-back programme 28 May 2019 – 3 June 2019

Amsterdam/'s-Hertogenbosch, the Netherlands, 4 June 2019

In the period from 28 May 2019 until 3 June 2019 Van Lanschot Kempen has repurchased 42,219 of its own shares (depository receipts for Class A ordinary shares). The shares were repurchased at an average price of €20.69 per share for a total amount of €873,667.

These repurchases are part of the share buy-back programme for at most 370,000 of own shares, which was announced on 21 February 2019. The total number of shares repurchased to date is 345,350.
