Van Lanschot Kempfen: update on share buy-back programme 10 May 2022 – 16 May 2022

In the period from 10 May 2022 until 16 May 2022 Van Lanschot Kempfen has repurchased 12,557 of its own shares (depository receipts for Class A ordinary shares). The shares were repurchased at an average price of €25.00 per share for a total amount of €313,868.

These repurchases are part of the share buy-back programme for at most 600,000 of own shares, which was announced on 24 February 2022. The total number of shares repurchased to date is 343,354.
